- General Information that includes ALL of the following:
 - A. Proposed title of workshop (12 word limit)
- B. Workshop length (1.5 hours): There will be approximately 15 1.5hour slots in the conference.

- C. Lead presenter information: The lead presenter is our primary contact and must distribute information to all other presenters. Include name, credentials, address, work and home phone numbers, fax number, and e-mail address. (Email will be primary contact method).
- D. Additional presenter information: Include all information listed above for each presenter.
- E. Level of practice (Intermediate or advanced): Basic presentations not desired.
- F. Special Considerations: Standard workshop set up is theater style. Please describe any special set up needs (desks, roundtables, circle, etc.) or special considerations (high noise level, etc).?
 - 2. Proposal abstract including ALL of the following:
- A. Paragraph description (50 words or less) describing the topic and content of the presentation. This will be printed as the workshop description in the conference brochure.
- B. Learning objectives: Three learning objectives for each hour of presentation.
- C. Outline: Provide a basic outline of all content for review by the Conference Committee.
- D. Powerpoint Presentation: submit outline of presentation on powerpoint, or full powerpoint.

- B. Resume or CV for EACH presenter. Presenters will be evaluated on their expertise on the proposed topic, and on documented experience providing professional presentations.
